


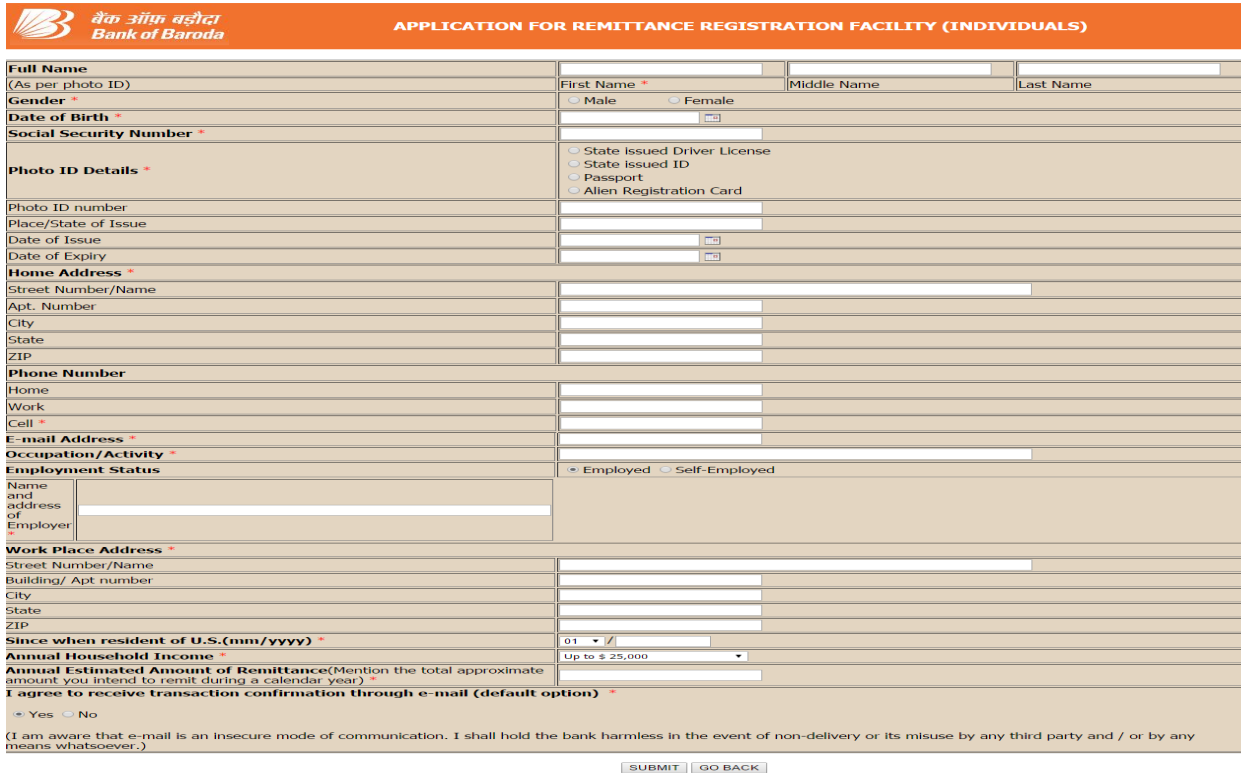
# REMITTANCE REGISTRATION FACILITY FOR INDIVIDUALS

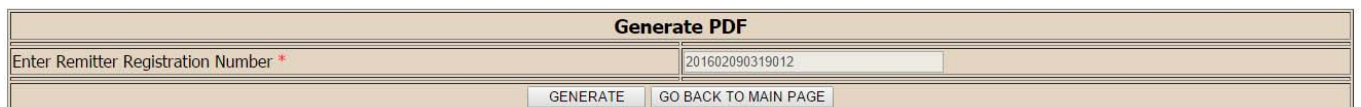

7. After uploading the documents, the originals be presented in person or sent by US mail/courier to the following address:

After receiving original documents, Bank shall provide a **Remitter Registration Number /User ID** on e-mail address or by U.S. Mail. Password (Sign-on and Transaction) shall be provided on the mailing address.

Once remitter has User ID and Password he/she can provide remittance information online through our remittance portal.

## Guidance for Online Rupee Remittance

1. When a remitter intends to remit funds to India then he/she should first check our exchange rates available on our website [www.bankofbaroda-usa.com](http://www.bankofbaroda-usa.com) and transfer the funds in USD from his/ her account to any one of our following accounts:

The Remittance Registration Number allotted and intimated by us through your email should be mentioned in the online transfer. **Remittance will be effected only after receipt of the online transfer request and funds in any one of the above mentioned accounts.**

2. After transferring the Funds, the remitter should click on link “Registered? Click Here” and login in Retail User with the User ID and Password.

## Rupees Remittance to India

### Frequently Asked Questions (FAQ)

#### **Who can register ?**

All US residents can apply for remittance registration . Applicants are required to provide acceptable proof of identity and current residence. They are also required to disclose the source of funds and the current annual income.

#### **Can I send money to any bank or should it be to Bank of Baroda only?**

You may send money to any bank in India. We would be remitting the funds to our designated branch in Mumbai and they in turn would remit to beneficiary bank through RTGS/NEFT.

#### **How many days would it take to remit the funds to India?**

Same day in case of Beneficiary account is with Bank of Baroda and second working day (India) in case of beneficiary account with other banks.

#### **Is it necessary to come to the bank for registration or for sending remittances ?**

No , it is not necessary. You may submit the registration form or remittance form online.

#### **Do I need to have an account for sending remittance ?**

It is not necessary to maintain an account with us.

#### **At what rate are US Dollars converted to Indian Rupees ?**

The conversion of US dollars into Indian Rupees will be done at the rate determined by Bank of Baroda , New York on the day of the remittance transaction. The daily exchange rate please visit our web site :<http://www.bankofbaroda.com>

#### **What are the service charges for remittance ?**

All rupee remittance through our Rupees Remittance facility are free.
